Allianz Insurance is one of the largest general insurers in the UK and part of the global Allianz Group.

Allianz Group employs 147,000 employees worldwide and serves 100M customers across more than 70 countries. Global gross written premium totaled EUR 906 billion in 2019. ## **When building a successful portfolio.**

## Solar Panels
